City of Papillion Tournament Application and Agreement

The following requirements have been established for individuals and organizations that desire to reserve the City of Papillion's outdoor facilities for the purpose of holding a tournament.

The City Recreation Director shall have the authority to grant the use of facilities for tournaments in accordance with the following requirements:

1. Facilities may be reserved for the purpose of holding a tournament on dates that do not conflict with the City of Papillion sponsored leagues or tournaments.
2. **Tournament Directors must submit proof of liability insurance with a minimum \$1,000,000 for each occurrence and \$5,000,000 in general aggregate. Policy must include the City of Papillion named as an additional insured. If this requirement is not fulfilled, the tournament will not be allowed to play on any of the City of Papillion fields.**
3. Tournament Directors must submit a 20% deposit and a copy of the application at the time the fields are reserved. The deposit will be applied to the final fee due to the Papillion Recreation Department. The deposit will be refunded only in the event that the tournament is rained out. Application and deposit must be submitted to the Papillion Recreation Department located at 1046 West Lincoln Street, Papillion, NE 68046.
4. Bracket information and proof of insurance must be turned into the Papillion Recreation Department office by 5:00 pm one week prior to your tournament. **NO EXCEPTIONS!**
5. **The balance of the tournament fees must be paid no later than 5:00 pm the Friday after the tournament. Future tournament requests may be cancelled for late payment or non-payment.**
6. The City of Papillion has the final decision on playable field conditions due to inclement weather or muddy fields. Rain-out dates cannot be replayed due to other scheduled tournaments and league games. If your tournament is rained out, a refund will be returned to the Tournament Director.
7. All tournament games may not begin before 8:00 am and must be completed by 11:00 pm. Any exceptions to this rule must have written confirmation from the City of Papillion.
8. The Papillion Recreation Department will provide concessions for all tournaments during the months of April through July. Tournaments cannot sell food items during this time frame. Any tournaments scheduled prior to or thereafter, must have written permission from the Recreation Director in order to sell concessions. Tournaments can sell items relative to the club or tournament such as t-shirts without a vendor application.
